CHC30113 Certificate III in Early Childhood Education and Care



The Certificate 3 Guarantee Program is funded by the Queensland Government Department of Employment, Small Business and Training (DESBT) for QLD citizens to complete Certificate III qualifications which lead to employment and enhanced career outcomes.

ECTARC

The Early Childhood Training And Resource Centre (ECTARC) is approved by the Department of Employment, Small Business and Training (DESBT) to deliver funded training under the Certificate 3 Guarantee Program. ECTARC is a not for profit, community owned Registered Training Organisation (RTO code: 90331) that specialises in early childhood training and professional development. Extensive knowledge of best practice in the early childhood sector and high quality student support is how we stand out from our competitors. Each student is allocated a personal Training and Development Officer (TDO) to support their learning journey.

DELIVERY MODE

The Certificate 3 Guarantee Program is a self-paced program undertaken via flexible delivery and includes a combination of phone support, free on-line webinars, self-paced learning materials, practical training and RPL. Participants must have access to a computer and the internet. ECTARC provides all other necessary resources free of charge.

There are two components to the qualification:

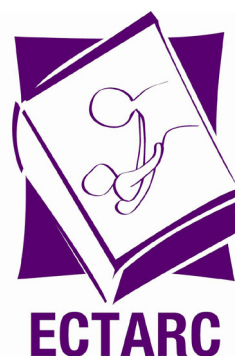
- Formal training and assessment by ECTARC
- Work Placement Hours – 120 hours of practical learning in the workplace to gain skills and knowledge.

The duration of the program will vary according to electives chosen and individual student skills, knowledge and experience. The program takes approximately 1 to 2 years to complete - the more study you do the quicker the course can be completed.

ECTARC will develop a training plan to suit your individual learning needs and time demands. Assessments will be a combination of written assignments, projects, observations in the workplace, competency conversation, and practical demonstration. All participants are required to complete a Foundation Skills Questionnaire which is designed to provide an indication of the individual needs of the learner.

WHO CAN APPLY

To be eligible to receive government funding under the Certificate 3 Guarantee program, individuals must:

- be aged 15 years or older;
- be no longer at school;
- permanently reside in Queensland;
- be an Australian citizen, Australian permanent resident (includes humanitarian entrant), temporary resident with the necessary visa and work permits on the pathway to permanent residency, or a New Zealand citizen; and
- not hold, and not be enrolled in, a Certificate III or higher-level qualification, not including qualifications completed at school and foundation skills training.

Note: The entitlement under the Certificate 3 Guarantee program is for one government subsidised Certificate III qualification only.

Additional requirements: Any person working with children must undergo a criminal history check and be eligible for a Positive Notice 'Blue Card'. Application forms are available from the Queensland Public Safety Business Agency at www.bluecard.qld.gov.au.

The first aid component HLTAID004 Provide an emergency first aid response in an education and care setting must be completed externally through a registered training provider of the student's choice. ECTARC will cover the cost on behalf of the students. The nominated registered training provider must invoice ECTARC for the cost of HLTAID004 Provide an emergency first aid response in an education and care setting and reference the student's name on the invoice. Payments will be made within 7 days of receiving the invoice.

FEES

All participants are required to contribute towards the cost of their training and assessment services. This is called a co-contribution fee. The participant co-contribution fees are calculated at a rate of 0.65c per nominal hour for each unit of competency being undertaken.
